Terms and Conditions

1. Definitions

- a. "Contract Documents" mean the Quotation together with the Order Acknowledgement Form, or a purchase order that is signed by the Seller, or a sub-contract or contract signed by the Seller.
- b. "Holiday" has the same meaning as set out in the Rules of Civil Procedure, R.R.O. 1990, Reg 194, as amended.
- c. "Order Acknowledgement Form" means the form provided by the Seller to the Purchaser acknowledging that the Seller has accepted the Purchaser's order based on the Seller's Quotation.
- d. "Purchaser" means the person, corporation, partnership, organization, or entity purchasing the products and/or services from the Seller.
- e. "Price List" means the Seller's itemized standard product prices used to form part of the Quotation.
- f. "Quotation" means the Seller's quotation for products and/or services to be provided by the Seller to the Purchaser, which includes any Work.
- g. "Seller" means M-Con Pipe and Products Inc.
- h. "Terms" means these Terms & Conditions of Sale.
- i. "Work" means any engineering, manufacture, and delivery of the products and/or services by the Seller, and/or any other work to be performed by the Seller or products and/or services to be delivered by the Seller, as set out in the Quotation.

2. General

- a. Quotations are open for acceptance within thirty (30) days of the date indicated on the Quotation, after which time, the Quotation is subject to change without any further notice by the Seller, including any prices listed therein.
- b. No contract shall be formed between the Seller and the Purchaser unless and until the Seller issues an Order Acknowledgment Form.
- c. No terms and conditions of sale shall be added by the Purchaser by use of purchase order or other means, notwithstanding what such documents may contain. The only Terms and Conditions that shall apply are those on the Contract Documents. These Terms prevail over any of Purchaser's general terms and conditions of purchase regardless of whether or when the Purchaser has submitted its purchase order or such terms. Fulfilment of the Purchaser's order does not constitute acceptance of any of the Purchaser's terms and conditions and does not serve to modify or amend these Terms. In the event of conflict between these Terms and any other document signed by the parties, these Terms prevail.
- d. Quotations are made by the Seller on the condition that delivery of the products and/or services be taken by the Purchaser within six (6) months from the date of the Purchaser's acceptance of the Quotation. Prices for any products and/or services delivered after six (6) months from the date of the Purchaser's acceptance of the Quotation are subject to change and will be billed to the Purchaser at the time of invoicing.
- e. It is the Purchaser's sole responsibility to, without limiting the generality of the foregoing, verify all quantities, calculations and specifications associated with delivery, and the Seller assumes no liability whatsoever for any errors in this regard.
- f. Unless quoted otherwise, the prices contained in the Price List are based on the use of Normal Portland Cement (Limestone), with rubber gaskets complying with CSA A257.3 and ASTM C443. A premium will be added by the Seller for any other type of cement or gasket required.
- g. Custom or speciality precast concrete products are not subject to cancellation once the Order Acknowledgment Form has been issued. Any products of such a nature will be invoiced in full to the Purchaser, even if no longer required or taken.
- h. Standard, stock items returned to the Seller will be subject to a 25% handling fee. Return of such items are subject to acceptance of the Seller, which the Seller may accept in its sole and unfettered discretion. Products picked up for credit will be subject to return freight charges.
- i. Any request by the Purchaser to change the quoted supply shall be made in writing, and only on acceptance of such changes by the Seller will the Seller be required to provide anything not listed in the Quotation, and the Seller shall be entitled to make such adjustments as are necessary to its quoted prices to reflect the changed scope of Work.
- j. The Seller is entitled to rely upon the accuracy and completeness of any plans, specifications, or other documents provided by the Purchaser. For greater clarity, the Purchaser agrees that the Seller assumes no liability or obligation in respect of any errors, omissions, or inconsistencies in the plans, specifications, or other documents, including but not limited to whether such documents comply with any applicable acts, regulations, rules, or by-laws.
- k. Products and/or services provided by the Seller are warranted to be free from defects for a period of one (1) year from the date of delivery or pick up, and the Seller's liability is limited to replacement or repair of the deficiencies during the one-year period. The Seller is not liable for any consequential or other damages that may arise as a result of a defective product. All other warranties, guarantees, representations, agreements, or other similar obligations, including but not limited to any implied warranties of quality or fitness for a particular purpose, are hereby excluded. No warranties, guarantees, representations, agreements, or other similar obligations exist outside of these Terms and Conditions.

3. Financial Matters

- a. Acceptance of the Quotation shall not obligate the Seller to provide anything contemplated therein until the Purchaser's credit is approved by the Seller's Credit Department. Orders must be placed by means of an Order Acknowledgment Form signed by an authorized representative of the Purchaser.
- b. Payment shall be net 30 days from the date of the invoice. The Purchaser is not entitled to withhold payment of any amount payable to the Seller for any reason whatsoever.
- c. The Seller reserves the right to invoice for any specialty or custom product in full within 90 days of the date indicated on the Order Acknowledgement Form whether or not such products have been delivered. The Seller reserves the right to collect an extra charge at the time of invoicing for any storage and/or disposal costs incurred.
- d. A 3% cash discount may be offered at the Seller's sole and unfettered discretion as an incentive for prompt payment, providing no amount is overdue and full payment is made by the 25th day of the month following. HST is not subject to the discount.
- e. Interest at a rate of 2% per month (24% per annum) will be charged on all overdue accounts.
- f. If the financial status of the Purchaser becomes unsatisfactory to the Seller in the Seller's sole and unfettered discretion, the Seller reserves the right to demand full payment in advance, or another form of agreed upon security, or withhold any Work, or if the Purchaser is in default of any of its obligations under the Contract Documents, to cancel the unfilled portion of the Quotation without penalty to the Seller.
- g. Federal and provincial taxes are additional. Any changes to the applicable tax legislation will be charged or credited accordingly.

4. Manufacturing & Delivery

- a. Unless otherwise noted in the Quotation, pricing includes deliveries being made during normal daylight working hours from Monday to Friday, not including any Holiday.
- b. To ensure adequate service, no less than 48 hours' notice shall be given to enable proper scheduling of deliveries.
- c. Any expected completion, delivery or pick up dates that have been communicated by the Seller are approximate only and are not a guarantee. For greater clarity, the Seller does not and can not guarantee any particular date for its performance. The Seller shall not be liable for loss or damage of any kind to the Purchaser resulting from a failure to deliver on any particular date or dates.
- d. Delivery will be made at the delivery address specified in the Quotation.
- e. Quoted prices include delivery for truckload quantities within a 250 kilometer travel distance from the Seller's plant. Deliveries which exceed the set limit will be subject to a flat delivery charge. A truckload consists of a minimum of a 32,000 kilogram payload.
- f. Any order less than the minimum will be priced FOB the Seller's plant, with delivery charges as an extra at time of invoicing.
- g. When delivery is quoted as "FOB Truck at Jobsite", delivery shall be construed to mean motor truck delivery, not unloaded, as close to jobsite, designated storage area, or to the line of the trench as is practical for the loaded motor trucks and trailers to operate under their own power without risk of accident, injury, or undue delay. The Purchaser shall provide and maintain suitable access roads to project site for delivery of the goods. Delivery beyond a point accessible to loaded trucks shall be at the risk of the Purchaser. The Purchaser shall be solely responsible for any accident or damage resulting from failure to provide safe and satisfactory access to jobsite.
- h. The Seller reserves the right to collect an extra charge at the time of invoicing for any delay of sixty (60) minutes or more in the unloading or releasing of their transports.
- i. An allowance of five percent (5%) from the net price may be made at the Seller's sole and unfettered for concrete products picked up at the Seller's yard (not applicable to all products).
- j. The purchaser shall inspect all products purchased at time of delivery and any claims in respect thereto must be made at that time. To avoid unnecessary costs and delays, special attention should be given to specialty or custom products. If any such goods are found to be defective in the sole and unfettered discretion of the Seller, the Seller will deliver new goods to the Purchaser at the site of work. It is a condition of sale that this will be the limit of the Seller's liability and that the Seller will not be liable for any labour or equipment costs or other consequential damages.

5. General

- a. The Seller shall not be held liable, nor deemed to have defaulted under or breached the Contract Documents, for any failure or delay in fulfilling or performing any term of the Contract Documents, when the failure or delay is caused by (a) acts of God; (b) flood, tsunami, fire, earthquake, hurricane, tornado, explosion; (c) epidemics, pandemics (including the 2019 novel coronavirus pandemic (COVID-19)), and any other public health crisis; (d) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot, or other civil unrest; (e) government order, law or actions; (f) embargoes or blockades in effect on or after the date of the Contract Documents; (g) national or regional emergency; (h) strikes, lockouts, labour stoppages or slowdowns, labour disputes, or other industrial disturbances; (i) shortage of adequate power or telecommunications or transportation facilities; (j) failure of any governmental or public authority to grant a necessary licence or consent; and (k) other events beyond the reasonable control of the Seller.
- b. Waiver of any one or more of the terms or conditions herein by the Seller shall not constitute a general waiver of the terms and conditions, and the Seller reserves the right to enforce any and all terms and conditions not so waived. Any such waiver must be in writing by the Seller.
- c. Any disputes arising from the interpretation of the Quotation, the Order Acknowledgement Form, or these Terms & Conditions shall be governed by the laws of the Province of Ontario, and each party agrees that it attorns to the jurisdiction of the courts of Ontario in connection with these minutes of settlement, and the Purchaser agrees to pay the Seller's legal costs on a full indemnity basis in respect of any such dispute.
- d. If any term or provision of the Contract Documents is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of the Contract Documents, or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon a determination that any term or provision is invalid, illegal or unenforceable, the parties shall negotiate in good faith to modify the Contract Documents to effect the original intent of the parties as closely as possible in order that the transactions contemplated therein be consummated as originally contemplated to the greatest extent possible.
